

## CANDIDATE AGREEMENT

In consideration of my participation as a Candidate in the Defeat of Jesse James Days Ambassador Scholarship Program, I hereby agree:

1. I have voluntarily entered the Defeat of Jesse James Days Ambassador Scholarship Program. I understand my sponsor will be contributing a substantial sponsorship fee for my participation, and therefore, I hereby express my intent to participate in the Candidate Experience.
2. The Defeat of Jesse James Days Committee may use my likeness/photographs/ voice recording, autograph and name in such manner as they see fit for publicity and commercial purposes.
3. I hereby release the Defeat of Jesse James Days, its officers, directors and any other business or individuals connected therewith, from responsibility in connection with any injuries sustained by me in my capacity as a Candidate from the Defeat of Jesse James Days Ambassador Scholarship Program.
4. I agree to abide by the rules set forth by the Defeat of Jesse James Days Ambassador Scholarship Program regarding Candidate participation, behavior and expectations; including:
  - A) A Candidate shall not at any time, regardless of the quantity,
    1. use, consume or have in possession a beverage containing alcohol;
    2. use, consume or have in possession tobacco; or,
    3. use, consume or have in possession, buy, sell or give away any other controlled substance; Any violation may result in the Candidate to be immediately dismissed from participation in the Ambassador Program.
  - B) If arrested for any misdemeanor or greater offense you are subject to disciplinary action that could result in the immediate dismissal of the Candidate from the Defeat of Jesse James Days Ambassador Program.
  - C) During official appearances need to conduct themselves with respect, discretion and decorum.
  - D) All "Official Candidate Attire" shall be removed when not performing office duties (this is for safety purposes).
  - E) Requests for personal appearances/advertising/interviews by the Ambassador Candidates must be approved by the Chairperson of the DJJD Ambassador Program Committee.
  - F) Before making any plans to be absent from Northfield or taking a long trip, the Ambassador Candidates should consult with the DJJD Ambassador Program Committee in order to facilitate the scheduling of events. Without prior approval, all candidates are required to be present at all functions planned for the candidates, until the end of the celebration.
  - G) Chaperones will be with the Candidates at all scheduled appearances. Candidates should not request adjustments of set plans or to make necessary a premature departure from an event.
  - H) Ambassador Candidates shall not authorize any charges (clothing etc.) against the DJJD Ambassador Program Committee.
  - I) If selected as a Defeat of Jesse James Days Ambassador, I agree to relinquish any and all other titles immediately.
5. I have read the rules applicable to candidates set forth by the Defeat of Jesse James Days Ambassador Scholarship Committee, and I agree that any decisions rendered by the committee in its interpretation of rule violations are within their discretion and are final. I have read, understand and agree to this Agreement.
